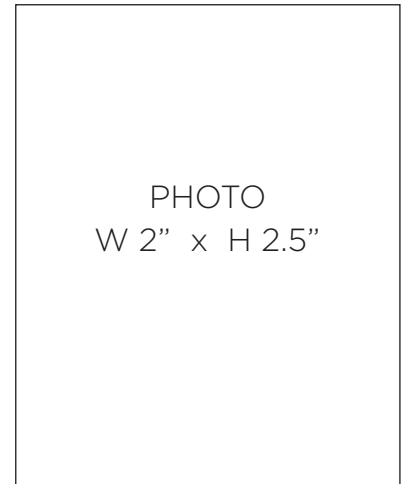

## Those Days • These Songs Singing Contest Season 3 Application Terms and Regulations

### 1. Foreword

- a. Those Days • These Songs Singing Contest Season 3 (hereinafter the “Contest”) is organized by Fairchild Television Ltd. (hereinafter the “Organizer”). The Contestant must participate by way of solo or group performance (hereinafter the “Contestant”).
- b. The Contestant must select one song from 80s to 00s as his/her contesting song. The duration of the audition song should be between 2 minutes 30 seconds and 3 minutes.
- c. For group performance, each member is required to submit a separate application form and a separate application fee.
- d. The panel of judges will set its adjudicating standard based on the following criteria:
  - i. showmanship
  - ii. voice quality
  - iii. music sense
  - iv. technique
- e. The Organizer shall have the absolute right to decide upon and arrange television production and broadcast of the Contest.
- f. The Contestant agrees to be bound by and comply with these terms and regulations listed below.

### 2. Qualifications of the Contestant

- a. Applicant must be Chinese from all age groups.
- b. The Contestant must be a citizen, permanent resident or a person who with open work permit in Canada.
- c. The Organizer shall have the right to waive or modify the above qualifications in relation to any Contestant with regards to the information provided by the Contestant.
- d. The Contestant shall not be bound by any legally binding agreement which will prevent or prohibit him/ her from entering into a performance agreement which may be entered into by the Contestant and the Organizer.
- e. The individual who is an employee of, or a family member of an employee of the Organizer Fairchild Television, and Co-organizers Talentvision TV, Fairchild Radio and Popular Lifestyle & Entertainment, is not eligible to participate in the contest.

### 3. Application Details

- a. The Contestant shall complete and sign the application form, and must submit together with the following documents and fee:
  - i. A photocopy of the Contestant’s driver’s license, passport, or other valid picture identification;
  - ii. A photograph of the Contestant from the waist up;
- b. Application fee
  - i. Before the deadline on April 17, 2026 (Friday) at 5pm, the fee is CAD45 (tax included, cash or via PayPal).
  - ii. On April 19, 2026 (Sunday), the on-site application fee is CAD60 (tax included, cash only).
  - iii. The application fee is non-refundable.
- c. The Contestant can submit the completed application form and fee either online or in-person submit the completed form, along with relevant documents and fee (cash only) to Fairchild Television. On-site application contestants must personally submit the completed form and fee at the audition venue during the specified audition period.
  - i. Online Submission  
The Contestant is required to upload the instrumental music of the audition song (WAV/MP3 format) to [ftvsingingcontest.ca](http://ftvsingingcontest.ca) (up to 10MB) and pay the fee of CAD45 (tax included) online through PayPal.
  - ii. In-Person Submission  
The contestant is required to submit a USB with instrumental music of the audition song (WAV/MP3 format), along with the completed application form, relevant documents, and the fee of CAD45 (tax included, cash only) to Fairchild Television Unit #8, 35 East Beaver Creek Road, Richmond Hill ON.
  - iii. On-site Submission  
The contestant is required to submit the completed application form, a fee of CAD60 (tax included, cash only) and a USB with instrumental music of the audition song (WAV/MP3 format) at the audition venue within the specified audition period. The organizer will not accept instrumental music through mobile phones.

### 5. Declarations

- a. The Contestant understands and agrees that the Organizer has the absolute right at any time to:
  - i. Refuse any application without explanation;
  - ii. Select or disqualify any Contestant at its sole discretion;
  - iii. Determine the number of Contestants and approve song choices;
  - iv. Amend, suspend, or cancel dates, venues, or regulations without prior notice.
- b. The Contestant further agrees:
  - i. That The Organizer may retain all submitted documents and fees;
  - ii. The Organizer is not liable for any losses or injuries (including fatal injuries) arising from participation, regardless of negligence;
  - iii. To abide by the decisions of the judges and the Organizer regarding styling (hair, makeup, and costume);
  - iv. To participate in all promotional activities as directed; failure to attend scheduled activities may result in disqualification;
  - v. All proprietary and intellectual property rights resulting from the Contest vest solely in the Organizer;
  - vi. All proprietary rights in relation to any audition, performer or other product of the Contestant in relation to the Contest will vest solely in the Organizer.
  - vii. Finalists who win any title in the Final are required to enter into a one-year management contract with Fairchild Television Ltd.

### 6. Confirmation

The Contestant confirms that the information given in this application form is true and correct. No images or other documents provided by the Contestant are or may be subject to third party copyright or any other third party legal or moral rights or claims. The Organizer will not be responsible for any lost, stolen, damaged, misdirected or destroyed application forms or other documents or for any human or technical errors in the processing thereof. The Contest is governed by the laws of Ontario and the laws of Canada applicable in Ontario.

### 7. Language

This Application Terms and Regulations is written in both English and Chinese. In case of variance or discrepancies between the two versions, the English version shall prevail.

## 那些年·這些歌 精選歌曲大賽 第三季 條款及規則

### 1. 前言

- 那些年·這些歌精選歌曲大賽 第三季 (以下簡稱「比賽」) 由新時代電視 (以下簡稱「主辦機構」) 主辦, 比賽可以個人獨唱或組合形式參加 (以下簡稱「參賽者」)。
- 參賽者需選擇一首80至千禧年代流行精選歌曲作為參賽曲目。面試歌曲長度限制為2分30秒至3分鐘。
- 如以組合形式參賽, 各成員需填寫獨立表格, 並各自繳付報名費。
- 評判團將依據下列各項內容對參賽者之評審標準;
  - 台風
  - 音質
  - 音樂感
  - 技巧
- 主辦機構有權自行決定製作有關之電視節目及進行電視廣播。
- 參賽者同意遵守一切申請條件及規則。

### 2. 參賽資格

- 參賽者為不限年齡的華裔人士。
- 參賽者必須在加拿大居住。
- 根據參賽者提供的資料, 主辦機構有權豁免及放寬參賽條件。
- 參賽者必須不受任何合約束縛, 以致不能簽署及履行主辦機構之合約。
- 參賽者不得為主辦機構新時代電視或協辦機構城市電視、加拿大中文電台及娛樂生活雜誌之僱員或其家屬, 以示公允。
